Maintenance Superintendent Brent Powers' Report

City Manager Tami Schuelke-Sampson Report

- A. Enclosed in the packets is the information and cost estimates for doing the repairs to the library/apartment building. The approved proposal to get the construction documents for reroofing and interior repairs that includes priorities H-1 to H-6 which are all the high priority items. This is the next step for applying for the next Minnesota Historical Society grant.
- B. A representative from the Disabled American Veterans stoped in the office today asking if they can put a clothes drop bin by the pop machine on the northwest corner of the building. It will be up against the building. Council stated they are OK with this as long as there are no bags left beside the drop bin and it is picked up regularly.
